Ladies Reflections-- Meeting via Zoom. Group pays for charge the host has for the Zoom Room. They are not sure when they are going back to in person meetings. They are paying rent. Contributions for 7th tradition are mailed into the treasurer. Reluctance on Venmo. Zoom is working great for them. Independence Center is interested in joining, but tech problems on their part. Participation is steady. One of their group members started a daily 1pm meeting.

Spiritual Actions—Steady attendance. The church has opened up for them at 14th and Calvert. Had a blend of a meeting. Some were present on Zoom and some in person. 7th tradition is lacking, not a huge effort has been made and Mike is going to make announcement about it. 10-12 in attendance.

Sufficient Substitute-- Not meeting in person, they are going to talk about it at the end of the month. Just set up Venmo account. Concerned about anonymity . Did disbursements. About 25 people in attendance.

Seeking Solutions-- Been pretty full 35-45 in attendance. Does have Venmo set up. Is paying rent to hold spot at church Made disbursements. Talked about opening back up, but tabled for now. Treasurer puts in chat box about venmo with information and they also have a way to mail in 7th tradition as well.
