Committee Reports

- Corrections: spending report/budget submitted, \$30 rent, \$189.93 literature, \$219.93 total. 2021 budget \$60 rent, \$240 hardcovers, \$210 soft cover 12x12, \$25 copies, \$535 total. \$390 balance this date. Nothing new from DOC to report. Paper had a lengthy report on current drug use in the work release program. Wish they could be there volunteering to provide support.
- Special Events: Nothing to report, but wanted to ask thoughts of the groups because the committee bought 45lbs of prime rib back in March. Proposed the idea of sending it to Matt Talbott, please ask your groups and report thoughts back in January.
- Treatment: got together last month, will request the same budget as last year. Spent about \$400 on literature for treatment centers. Current balance \$367.15. Treatment Committee couldn't get specific answers as to what happens with GrapeVines that are received. Decided to not send more GrapeVines at this time. Decided its best to use funds for Big Books.
- PICPC: No report, committee member believes budget request will be the same but confirm with IG representative to know for sure. They haven't been meeting regularly.
- Hotline: met Tuesday, discussed changes to the Flyer, have been working with web admin and checking out the new sign up form. It is nearly ready. Don't anticipate spending anything next year.
- Central Office: Meet Quarterly, 21st of January 2021, 7pm Hybrid via Zoom and Central Office
- Website: apologies for missing last month. Requesting the same budget for 2021. Largest expense comes every 3 years to renew the hosting contract. We have 2 urls. Lincaa.org and lincolnaa.org Do we want to keep that? See email about the sign up form to check out the hotline sign up form. Issue with androids to toggle between text fields/radio/check boxes but does work. Changes being made to the test site in regards to menu and announcements. Member questions cost of keeping the unused lincolnaa.org website. \$15/year is the cost per website. Can that website be linked to lincaa.org? There may be people getting lost in "the website cannot be reached."
