Budget Discussion:

A motion was made, seconded, and voted to table the discussion and approval of next year's budget for next meeting.

Currently, the Proposed 2025 Intergoup Budget is \$6,357 \$20 - Hotline \$120 - Treatment \$350 - Web \$452 - Intergroup Office Supplies, PO Box, etc. \$525 - PICPC \$690 - Corrections \$4200 - Special Events

\$3,175 - Prudent Reserve (which is 6 months of Intergroup's operating costs)

A member mentioned: If contributions are similar to last year. . .

\$2490 - from groups \$1830 - from Special Event contributions

... the proposed budget and prudent reserve "should" work. However, there was discussion about Special Events and their funding.

Special Events explained their \$4200 budget: \$800 - St Patrick's Day \$500 - Easter \$300 - Lake Day 1 \$600 - 4th of July \$300 - Lake Day 2 \$700 - Soberfest \$1000 - Holiday Dinner

There was discussion that Special Events Committee could fluctuate and update their funding throughout the year, event-to-event: If money isn't available, the budget for later events could be lowered. A member pointed out that Special Event's Committee isn't asking for \$4,200 from Intergroup because they have their own resources (raffles, 7th tradition, and other forms of donations) to fund / self-support their events. Therefore, the \$4,200 number could be misleading. The discussion revolved around the idea of Special Events getting seed money from intergroup and lowering the \$4200 amount.

Motion was made and passed to table the discussion and continue the discussion next month.
